In order to protect fellow Aggies' privacy as well as the integrity of the records, this information is available only to designated staff members by the Dean in the attached Statement of Responsibility. Access to this information by any third party is a violation of this agreement.

The information provided by The Association of Former Students and the Texas A&M Foundation should only be used to perform job responsibilities. Prohibited uses include, but are not limited to, any personal, political, religious, or commercial use, to create outside electronic files or databases as well as any use not directly tied to the business and benefit of The Association of Former Students or the Texas A&M Foundation.


