Kathleen will serve as The Association of Former Students' Chair of the Board in 2014. Medical Foundation Oct. 1, 2012, after serving on the Board of Trustees, the Investments Committee, and as Executive Vice President beginning in March 2012. She joined Citibank in November 2006, as Head of Citibank Texas Commercial and President of Citibank Texas. He was Texas A&M's first full-time assistant athletic trainer and was later named Head Athletic Trainer for all

men's and women's sports within the university. David spent eight years with Adidas before joining Nike as a regional apparel sales manager in Dallas in 1990. After nearly 18 years of service to The Association, Porter was unanimously elected by the Board of Directors in January 2000 to lead the organization, making him only the seventh chief executive in this position in The

Today, he is leading initiatives to achieve The Association's vision to become the premier alumni association and enhance Association services and broaden the organization's reach and relevance to the worldwide Aggie Network. # Gregory M. Cokinos '79



Principal – Cokinos, Bosien & Young Houston, Texas

Gregory graduated from Texas A&M University in 1979 with a bachelor's degree in business administration and received a J.D. from South Texas College of Law in December 1981. For more than 30 years, he has concentrated his practice in commercial litigation and transactions, both nationally and internationally. A founder of Cokinos, Bosien & Young, along with two other former students, his law firm has grown and is considered to be the largest law firm in Texas with a focus on

construction and engineering law, having offices in Houston, Dallas and San Antonio. Gregory's experience includes all aspects of commercial and industrial real estate construction and development, including office buildings, high rise condominiums, health care facilities, power plants, processing plants, refineries, pipelines, highway construction, as well as offshore production and drilling platforms. Although his practice is concentrated in the area of construction and real estate development issues, the firm handles a wide range of litigation matters as well as contract negotiations, including significant cases in virtually every area of commercial law, securities fraud, patent infringement, employment, banking, franchise agreements and oil and gas. Gregory is a member of the American College of Construction Lawyers and was the first lawyer from the City of Houston inducted into this prestigious organization. He has been named as one of The Top 100 Super Lawyers in the State of Texas by Texas Monthly every year since 2007. He was instrumental in the creation of the Construction Law Journal and has been the Journal's only editor since creation. Chairman, CEO and President – Chaparral Energy Edmond, Oklahoma

Mark graduated from Texas A&M University in 1972 with a bachelor's degree with honors in aerospace engineering. He began his career with Exxon Company USA that same year in the Permian Basin of West Texas where he held various positions as production engineer, reservoir engineer, field superintendent and finally supervising production engineer. From 1977 until 1980, Mark served as the drilling and production manager for the West Texas and then Mid-Continent Divisions of TXO

Production Corp. He held the position of division operations manager for Slawson Exploration Co. from 1980 until 1988, focusing on the Mid-Continent and Panhandle Divisions. In 1988, Mark founded Chaparral Energy where he has served as its President, Chief Executive Officer and Chairman of the Board since its inception. Chaparral is an independent oil and gas producer with headquarters in Oklahoma City, Oklahoma. Although predominately a Mid-Continent and Permian-Basin producer, the company has operations in eight states. Under his leadership, Chaparral Energy has grown in size to more than 800 employees in the company and has annual revenues in excess of \$500 million with an enterprise value approaching \$3.5 billion. Chaparral has received the Oklahoma City Metro 50 Award eight times and the prestigious Aggie 100 Award in 2006, 2007, 2008 and 2009. Mark is a member of the Society of Petroleum Engineers and the American Petroleum Institute (API). He served as a director of the API from 1984-1986. He currently owns and chairs the Board of Directors of Pointe Vista Development, LLC, Sumark Pharmacies, LLC and Dippin' Dots, LLC. He also sits on several non-profit organizations including the Boy Scouts of America. In 2012, Mark was a national finalist for the Ernst and Young Entrepreneur of the Year Award. As Laredo Energy's Chairman, CEO and a co-founder, Glenn Hart has contributed more than 30 years of experience to the company and its predecessor, as a successful developer of oil and gas resources throughout South Texas. Following graduation from Texas A&M University where he earned a Bachelor of Science degree in Petroleum Engineering, Glenn began his career as an engineer in the late 1970s with Tenneco Oil Co.'s Gulf Coast Division. He moved on to serve as an engineering

manager for Sanchez-O'Brien Oil & Gas Company before founding Michael Petroleum in 1983. In 2001, Houston-based Michael Petroleum was sold to Calpine Natural Gas and, with other members of his management team, Glenn formed Laredo Energy. He holds membership in the Society of Petroleum Engineers and the Independent Petroleum Association of America. Arena Ventures also developed the Laredo Entertainment Center, now known as Laredo Energy Arena, and the surrounding property which is home to many varied sports and entertainment events. He was also a founder of the Spirit Ice Arena located in College Station and has served as a deacon of the Second Baptist Church of Houston. He currently is an Elder at Faith Bible Church of Brazos County, near their part-time residence at their ranch near Kurten, Texas. 


Michele A. Mobley '87 Partner – DuBois, Bryant and Campbell LLP
